- The 12ist of the Officers who attended the meeting is herewith enclosed.
- The Principal Secretary to Govt. Social Welfare and Tribal Welfare
 Departments, while welcoming Sri Nakka Ananda Babu, Hon'ble Minister
 for SWE & TWE, has explained the progress made in implementation of the
 Scheduled Castes Component and Scheduled Tribes Component 2017-18
 and requested the Hon'ble Minister to address the house.
- Sri Nakka Ananda Babu, Hon'ble Minister for SWE & TWE, in his remarks, advised to expedite the process of incurring expenditure, by taking all necessary action and see that funds allocated are not lapsed.
- He also, reiterated that Departments should device special schemes that benefit SC/ST communities and the SCC and STC budget should not be spent on the general schemes.
- He added that. Departments need to ensure issuing of GOs as soon as Minutes of the Nodal Agency Meeting are received, which would facilitate the implementation of the schemes / execution of the works.
- The Nodal Agency has reviewed the Agenda items item wise and the following resolutions were passed.

AGENDA NO.1

APPROVAL OF ACTION PLANS FOR 2017-18

The Nodal Agency has instructed the Departments those who have not furnished the District wise Action Plans of 2017-18, to furnish the Action Plans within one week.

AGENDA NO.2

REVIEW OF EXPENDITURE UNDER SCHEDULED CASTES COMPONENT 2017-18

Resolution: The Nodal Agency has reviewed the expenditure under Scheduled Castes Component (earlier SCSP) 2017-18 as on 28.01.2018 and issued the following instructions.

- The performance of the departments viz.. Registrar of Co-Operative Societies. AYUSH, Cultural Affairs and Ground Water are not satisfactory and hence decided not to allocate the budget under Scheduled Castes Component for the year 2018-19. However, they may approach with a detailed plan of action for consideration by the Nodal Agency.
- Department of Agriculture has been directed to prepare a model plan which will reduce the burden of own contribution by Scheduled Caste farmers, to derive the benefits of farm mechanisation scheme, by converging subsidy and soft loan components.
- Department of Fisheries has been advised to prepare a livelihood Action Plan and ensure that the benefit should go to the community and their empowerment. Further advised to supply motorized boats, wherever feasible to keep the fishermen away from money lenders and middlemen.
- The Nodal Agency has agreed to provide the following to the Department of Women and Child Welfare during the year 2018-19
 - An amount of Rs.200.00 Crores to be allocated towards providing special nutrition to address malnutrition among Pregnant, Lactating Women and Children belonging to Scheduled Castes.
 - Rs.159.80 Crores to be allocated for construction of 1400
 AWC buildings in SC locations.
- The Nodal Agency has agreed to provide the following to the Department of Family Welfare for the year 2018-19.
 - An amount of Rs.76.17 Crores to be allocated towards the new scheme. Strengthening of Medical Infrastructure under

Scheduled Castes Component" with a aim to provide additional infrastructure for APVVP Hospitals located in SC Assembly Constituencies in the State.

 The Nodal Agency has agreed to provide Rs.1100.00 Crores keeping in view the anticipated spill over amount to the Panchayat Raj Engineering Dept, as detailed below.

Resolution: The Nodal Agency has accepted the above revised proposal and ensure that the programme of grounding of livelihoods and details of beneficiaries shall be uploaded in SCSP Web portal.

II. New Works/New Proposals:

1.Panchayat Raj Engineering Dept:

Social Welfare Dept vide Memo No.33025-68/SW.SCP.A2/2018 Dt.25.01.2018 requested to place the matter for sanction of "5 CC Road works in SC Colonies of (i) Kotkesavaram (V),Korukonda (M), (ii)Butchmapeta (V), Korukonda (M), (iii) Jaganadhapuram (V), Korukonda (M), (iv) Pallakadiam (V), Rajanagaram (M) and (v) Mukkinada (V), Rajanaragarm (M) of Rajanaragaram Constituency,East Godavari District with an estimated cost of Rs.436.00 lakhs".

Resolution: The Nodal Agency has approved the above works and recommended to place before the State Council for Development of SCs and STs.

2. Animal Husbandry Dept:

The Director of Animal Husbandry Dept has submitted that the Nodal Agency approved the Action Plan during its 16th meeting held on 23.06.2017. Among the approved schemes "Heifer Induction" is one among them. Main aim of the scheme is increase of milk production through replacement of breeding stock by way of heifer induction followed by rearing support to reduce the age at first conception in female cattle. The Director of Animal Husbandry has submitted that after midterm

appraisal of the scheme it is revealed that due to non-availability of pregnant heifers the implementation of the scheme is poor. He has requested to modify the scheme to supply of milch animals/Pregnant milch animals in addition to the pregnant heifer induction. Further the animals reared by the SC farmers suffer from mineral deficiency due to low plane of nutrition on account of poor finance status of them and hence to supply mineral mixture on 90% subsidy instead of supplying the input free of cost. The Director of Animal Husbandry therefore requested for inclusion of these sub-scheme in Heifer induction programme as the Department will meet the cost within the existing BE provision from out of the savings among the approved schemes.

Resolution: The Nodal Agency has approved the inclusion of the following two schemes under "Heifer induction Programme" (a) Milch Animal/Pregnant Milch Animals Scheme and (b) Supply of Mineral Mixture and resolved that the Administration Department shall take further necessary action in the matter and ensure the successful grounding of the scheme within the approved B.E.

3. Minor Irrigation Department (APSIDC):

The Joint Managing Director. A.P.State Irrigation Development Corporation Ltd. has submitted proposal to place before the Nodal Agency for revival of Nemali L.I Scheme on Anuradhvagu in Gampalagudem Mandal of Krishna district with an

estimated cost of Rs.28.21 lakhs to befit about 57.46% SC farmers under the ayacut. (Lr.Rc.No.IDC/JMD/DEE(3)/AE/Krishna/NemaliLIS/2017-18/2411 dt.30.01.2018).

Resolution: The Nodal Agency has approved the above works and recommended to place before the State Council for Development of SCs and STs for ratification.

Hon'ble Chairman of the Nodal Agency, has directed vide Note No.210 / M(SWE&TWE)/2018, Dt.30.01.2018, to place the matter relating to approval of 7 No. of Foot bridge works over KW Bank canal / channels in Guntur District with an estimated cost of Rs.222.07 lakhs. The list of the works is enclosed in the Annexure-IV.

Hence, it is placed before the Nodal Agency for approval.

Resolution: Nodal Agency has approved the above works subject to ratification by the State Council for Development of SCs & STs.

2. Municipal Administration & Urban Development Department:

Hon'ble Chairman of the Nodal Agency, has directed vide Note No.210 / M(SWE&TWE)/2018, Dt.30.01.2018, to place the matter relating to approval of 19 No.of CC roads and drains works in Kadiri Municipality, Ananthapuramu District with an estimated cost of Rs.177.90 lakhs. The list of the works is enclosed in the Annexure-V.

3. Rural Water Supply Department:

Hon'ble Chairman of the Nodal Agency, has directed vide Note No.210 / M(SWE&TWE)/2018. Dt.30.01.2018. to place the matter relating to approval of 67 No.of works (OHSR, Augmentation etc) with an estimated cost of Rs.1398.00 lakhs. in Vizianagaram. Nellore. Chittoor, Guntur and Visakhapatnam Districts. The list of the works is enclosed in the Annexure-VI.

4. R&B Department (State Roads):

Hon'ble Chairman of the Nodal Agency, has directed vide Note No.210 / M(SWE&TWE)/2018, Dt.30.01.2018, to place the matter relating to approval of 12 No.of road works with an estimated cost of Rs.2724.00 lakhs, in Guntur, Prakasam and Ananthapuramu Districts. The list of the works is enclosed in the Annexure-VII.

Hence, it is placed before the Nodal Agency for approval.

Resolution: Nodal Agency has approved the above works subject to ratification by the State Council for Development of SCs & STs.

III. Sanction of new schemes:

<u>Chandranna Pelli Kanuka</u>: The Government recognises the need for an intervention that addresses the financial difficulties faced by poor SC families while performing the marriage of girls. In furtherance of the recognition, the Government introduces a scheme – Chandranna Pelli Kaanuka for SCs, to provide to every unmarried girl belonging to the Scheduled Castes community, at the time of her marriage, a one-time financial assistance of Rs.40,000/- (Rupees Forty Thousand Only). subject to the eligibility guidelines. Approximately, 50,000 families are likely to be benefitted by this scheme and Rs.200.00 Crs would be required.

Hence, it is placed before the Nodal Agency for the approval of the scheme.

Resolution: The Nodal Agency has approved in principle the Chandranna Pelli Kanuka Scheme subject to ratification by the State Council for Development for SCs & STs and requested the Social Welfare Department to workout detailed modalities and guidelines for the implementation of the scheme.
